

Invoicing and Post RF settlement timetable

The purpose of this document is to provide clarity on the final deadlines for which Wholesalers and Retailers can invoice for positive sums and the deadlines for which a Post RF settlement run can be requested.

Invoicing for positive sums

As per the Business Terms and the Ofwat Customer Protection Code of Practice (CPCoP), Wholesalers and Retailers are able to invoice for positive sums for a period of 8 months after the publication of an RF settlement run. However, there are a number of actions that need to be carried out by MOSL in order for a Post RF settlement run to be scheduled and processed ahead of this window. To help manage expectations a deadline for Post RF settlement runs to be submitted to MOSL has been included in the timetable below.

Deadline for Post RF settlement runs

As per the Market Terms, Wholesalers and Retailers may request a Post RF settlement run for up to 28 months after the publication of the RF. This means that, for 8 months Wholesalers and Retailers would be able to request a Post RF settlement run and invoice for positive sums and for the following 20 months, Wholesalers and Retailers would still be able to request post RF settlement runs but would only be able to invoice for any negative sums.

Timetable

The timetable below lays out the deadlines for invoicing, Post-RF settlement run requests and the latest date that Post RF settlement run requests should be submitted to MOSL, to allow appropriate time for any settlement rerun to be processed ahead of invoicing deadlines.

Please note that the below dates are subject to change if there are any changes with the MOSL maintenance schedule. The current version may be found on the MOSL website within the CMOS subsection.

Invoice period – This refers to the relevant invoice period.

RF publication date – This refers to the date that the relevant invoice period would have an RF settlement report published.

Invoice deadline for positive sums – This refers to the final date that Wholesalers and Retailers are able to invoice for any positive sums.

MOSL submission deadline – This refers to the latest date that Wholesalers and Retailers are able to request a Post RF settlement run, in order for this to be carried out in time for the 8-month window for positive invoicing.

Deadline for Post RF settlement requests – This refers to the final date that Wholesalers and Retailers are able to request a Post RF settlement run.
